**NEW WATER AND SEWERAGE TARIFF FOR NYERI
WATER AND SEWERAGE COMPANY LIMITED
(NYEWASCO)**

Water Services Regulator Board has approved newly proposed water and sewerage tariffs for implementation by Nyewasco in line with Section 73 (5) of the Water Act.

By extension therefore, Tana Water Services Board (WSB) gives two months notice to all existing and potential water and sewerage customers of Nyewasco in Nyeri Municipality and its environs that constitute Chaka, Muringato River - KWS Mweiga corridor and Giakanja (Chorong'i area) that the tariff has been increased.

As per the Services Provision Agreement between TWSB and Nyewasco which is approved by the WATER SERVICES REGULATORY BOARD the areas of Nyeri Municipality, Chaka, Muringato River- KWS Mweiga corridor and Giakanja (Chorong'i area), shall pay the approved water and sewerage tariffs with effect from 1st January, 2009.

SEWERAGE

Sewerage shall be charged at 100% of water tariff and therefore corresponding consumer categories are charged equal rates to that of water.
