INVITATION FOR APPLICATIONS FOR A VACANT POSITION IN THE BOARD OF DIRECTORS OF NYERI WATER AND SANITATION COMPANY LIMITED

Nyeri Water and Sanitation Company (NYEWASCO) is a Limited Liability Company fully owned by the County Government of Nyeri and is one of the Water Service Providers in Nyeri County responsible for efficient and economical provision of water and sanitation services in Nyeri Central Sub County and its environs.

The Company seeks to fill the vacant position for the Board of Directors. The Board of Directors comprises the representatives of stakeholders identified by the Company and the County Government of Nyeri in accordance with the Water Sector Corporate Governance Guidelines of 2018 issued by the Water Services Regulatory Board (WASREB).

ELIGIBILITY

To be eligible for appointment, one MUST meet the following criteria: -

- i. Minimum Bachelor's degree or equivalent qualification from a university recognized in Kenya i.e. Professional qualifications
- ii. Minimum seven (7) years working experience in the core profession or have run own enterprise for a minimum of (7) years
- iii. Must be nominated by a stakeholder group registered with NYEWASCO
- iv. Must meet leadership and integrity criteria under Chapter 6 of the Constitution of Kenya and meet Fit & Proper Test criteria from WASREB (attach copies of the following documents issued within the last 12 months):-
 - a) Valid Certificate of Good Conduct from the Directorate of Criminal Investigations (DCI)
 - b) Valid Clearance Certificate from an accredited Credit Reference Bureau (CRB)
 - c) Valid Clearance Certificate from Higher Education Loans Board (HELB)
 - d) Valid Tax Compliance Certificate from Kenya Revenue Authority (KRA)
 - e) Current clearance Certificate from Ethics and Anti-Corruption Commission (EACC)
 - f) Duly Filled Fit & proper Test Form witnessed by a commissioner for oaths or magistrate (form is available on NYEWASCO website www.nyewasco.co.ke)

- i. Suppliers and other trading associates of the Company are not eligible for directorship positions at the Company
- ii. Persons in current professional and social relationships with directors of the Company are not eligible to become directors of the Company.
